NOTICE OF ELECTION AND CALL FOR NOMINATIONS FOR THE AFSSRN EXECUTIVE COMMITTEE (2024-2027)

as per the By-Laws (12 July 2019)

A. ELIGIBILITY

To be eligible to run as AFSSRN officer, the nominee must have been a full member of good standing (i.e., continuously active) in the Asian Fisheries Society and AFSSRN for the past three (3) years.

B. NOMINATION

- 1. Use the nomination form provided. It must be signed by the nominating member with the written consent of the nominee.
- 2. Submit the duly-accomplished nomination form to the Nominations and Elections Committee starting at 9:00AM (GMT +8) of 10 August 2024, to 7 September 2024, at 11:59PM (GMT+8), using the email address <u>afssrn.section@gmail.com</u>. In the email subject, write "Nomination: AFSSRN Execom". For the nomination form, please convert to pdf after it has been filled up, and use the file name "AFSSRN Nomination_Family name of nominee" (e.g., AFSSRN Nomination Santos).
- 3. The list of all qualified nominees shall be posted on the AFSSRN FB page on 11 September 2024.
- 4. Each of the qualified nominees shall submit a maximum of 250-word bionote with 2x2 photo, and a 150-word vision statement for AFSSRN. These shall be emailed to the Nominations and Elections Committee starting at 6:00AM (GMT+8) of 12 September 2024 until 16 September 2024 at 11:59PM (GMT+8), using also the email address afssrn.section@gmail.com. In the email subject, write "Family name of nominee: bionote with photo and vision for AFSSRN" (e.g.; Santos: bionote with photo and vision for AFSSRN). Indicate also the family name of the nominee in the attached files (e.g., Santos_bionote with photo; Santos_vision for AFSSRN)
- 5. The Nominations and Elections Committee shall disseminate by email the nominees' respective bionote with photo and vision statements for AFSSRN on 18 to 23 September 2024.

C. ELECTION

- 1. Nine members of the AFSSRN Execom 2024-2027 shall be elected online from among the nominees on 11 to 26 October 2024.
- 2. If insufficient nominations are received to fill all vacancies in the AFSSRN Executive Committee at the close of the Nomination period (7 September 2024 at 11:59PM GMT+8),

the nominees shall be deemed to be elected. Further nominations for the vacant slots shall be announced not later than 17 September 2024.

- 3. If at the close of the Nomination period (7 September 2024 at 11:59PM GMT+8), the number of nominations received is equal to the number of vacancies to be filled, all the nominees shall be deemed to be elected. No online elections shall then take place.
- 4. If at the close of the Nomination period (7 September 2024 at 11:59PM GMT+8), the number of nominations exceeds the number of vacancies to be filled, an online election shall be held starting at 8:00AM (GMT+8) of 11 October 2024 to 26 October 2024 at 11:59PM (GMT+8).
- 5. The officers of the Execom will consist of the Chair, Immediate Past Chair, Vice-Chair, Secretary, Treasurer, and five (5) members. The Officers of the different positions shall be elected by the members of the Executive Committee on its first committee meeting during the General Assembly on 6 November, 2024.
- 6. The three-year term of the Officers will commence on the day the election results are approved by the General Assembly.
