The Constitution and By-Laws of the AFS as follows:

- 1) Nominations of candidates for election as Councillors:
 - a) Shall be made in writing signed by two full members of the Society and accompanied by the written consent of the candidate (which may be endorsed on the form of nomination);
 - b) Shall be accompanied by a brief biography of the candidate;
 - c) Shall be delivered to the Executive Officer of the Society at least three months before the date fixed for the holding of the General Assembly;
 - d) Not more than two persons from the same nationality or from one country or territory in the Asia Pacific will be elected to the Council at the same time.
- 2) If insufficient nominations are received to fill all vacancies on the Council, the candidates nominated shall be deemed to be elected and further nominations for the vacant Council positions shall be received at the General Assembly.
- 3) If the number of nominations received is equal to the number of vacancies to be filled, the persons nominated shall be deemed to be elected.
- 4) If the number of nominations exceeds the number of vacancies to be filled, a ballot shall be held.
- 5) The ballot for the election of Councillors shall be conducted by using available secured mechanisms as decided by the Executive Committee and at the General Assembly in such usual and proper manner as the Council may direct.

Attention: AFS needs one more nominee to fill the position of councillor. The vacant Council position will be filled during the General Assembly (GA). The elections will be held during the General Assembly (GA), if the nominations receive more than one.
